This release is valid and effective whether the damage, loss, or death is a result of any act or omission on the part of any RELEASEES or from any other cause. This Waiver and Release of Liability includes, but is not limited to, injuries, or accidents, which may occur as a result of the: (a) use or misuse of the facility/owners premise in any way by anyone; (b) use of any equipment that malfunctions or breaks on owners premise; (c) improper maintenance of the facility, grounds, or any equipment on owners premise; (d) instruction or supervision while on owners premise; or (e) slipping, tripping and /or falling while on owners premise.

As consideration for being permitted by Owners to enter Owners premise to participate in Texas Youth Camp, INC activities, I hereby

agree that I, my assignees, heirs, guardians, and legal representatives will not make a claim against, or su e

Owners or its past, present or future parent, subsidiaries, affiliates, other related entities, successors, owners
